THREE SENTENCED TO SEWARD JAIL

Three men from the Construction Corps Camp, George Charlton, Lewis Slater and Paul Deiser, were on August 26th sentenced by U. S. Commissioner Eugene J. Carr to six months in jail and a fine of \$300 each after they had entered pleas of guilty to intoxication, disturbing the peace and assault.

When passing sontance Commis-

sioner Carr said:

"I just want to give you a little thought to earry in your mind. I wish it were within my power to sentence you to jail and horsewhip you. It is not within my jurisdiction, but it is within my jurisdiction to six months each in jail at Seward, and fine you each three hundred dollars. The \$300 fine will be suspended if you leave Alaska immediately upon your release from jail. I understand you brag of jail records. There is only one way to live, and that is to abide by the law. of

the country. If there is any violation of this sentance you will go to a Federal Penitentiary for ten years."

The men had returned to the camp from Matanuska and were creating a disturbance at 2 in the morning. When James Harrigan of the Colonial Police remonstrated with them the three men jumped on him, beating him so severely that he had to have treatment from Dr. Earl E. Ostrom for contusions of the face and body.

RIFLE CLUB BEING FORMED BY IRWIN

With Don L. Irwin's energy and enterprise behind it there is little doubt but what Palmer will soon have a rifle club that will be affiliated with the National Rifle Association of America.

Almost a hundred men have already signed up and more are coming in every day, says Mr. Irwin.

Members will be permitted purchase used Model 1917 Enfield Army rifles for \$7.50 or new guns for \$20.00. The more familiar Model 1903 Springfields will also be available at \$32.75 for new arms. No second hand guns of this type are sold.

The annual iscue, free of cost to members includes 120 Ball cartridges, .30, for rifle model 1903, and 200 Ball cartridges, caliber .22, but not to exceed 20,000 to any one club. There is also an issue of 100 targets, 10,000 pasters, six short and six mid-range spotters and 10 yards of target cloth.

Mr. Irwin hopes for an active club and is looking forward to competitive matches. If a good team is developed they will have an opportunity of competing with other clubs of the N. R. A.
